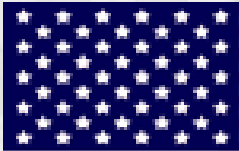

## DID YOU KNOW

I thought I would give this a try and see what kind of support I get for it. This is a column of little tidbits of information that may be helpful to club members. It can be anything - financial, great buys, new laws, travel tips, home repair, general how-tos, just anything that may be time or money saving to others. I know that every one of you has something you can submit to this column. Without your support, this won't last. I'll start this off with two or three things, and we'll see what you come up with for next month.

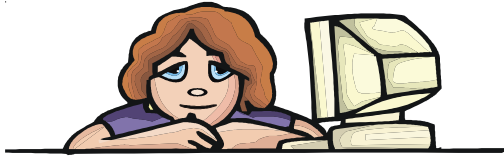
**How to start a screw.** This may sound like a simple thing. It works for all types of screws, but becomes very important when putting metal screws into a softer material like wood or plastic. It's very important in today's cars that have self-tapping screws into plastic. When you put the screws back into plastic, you want the screw to go back into the threads that were cut the first time, and not to cut new threads and weaken the material. Simply place the screw against the threaded hole and put a little bit of pressure against it and slowly turn the screw counter-clockwise, like you were trying to remove it. As you slowly turn it, you will feel it drop. It is now lined up with the original threads, and you safely screw it into the hole. And remember, when screwing into plastic, they just need to be snug. They strip very easily.

**A recent law change.** In California if you have to turn on your windshield wipers, your headlights must also be on. This has been the law for couple of years, but I find most people don't know it.

**An old law.** In California you cannot drive though a crosswalk if a pedestrian is in the crosswalk from curb to curb. This is a very expensive ticket, I believe in the thousand dollar range. I have been honked at several times for following this law, and a couple of weeks ago, a driver went around me, flipped me off and barely missed hitting a pedestrian.

**Gift Certificates.** In California a gift certificate or discount certificate that was bought, can never expire or have maintenance fees charged to it. If it is on a VISA type card it is exempt from the law. The big banks always win.

## CORNBREAD TOPPED SAUSAGE BAKE



---

### Ingredients

---

- 1 8.5-ounce package corn muffin mix
- 1 medium carrot, chopped (1/2 cup)
- 1/4 cup chopped onion
- 1/4 cup chopped green sweet pepper
- 1/4 cup chopped celery
- 2 tablespoons vegetable oil
- 1 11.5-ounce can condensed bean with bacon soup
- 3/4 cup milk
- 2 teaspoons yellow mustard
- 1 pound cooked smoked Polish sausage, sliced
- Shredded cheddar cheese (optional)

### Directions

---

1. Preheat oven to 425 degrees F. For corn bread, prepare muffin mix according to package directions (do not bake); set aside.
2. In a medium saucepan, cook carrot, onion, sweet pepper, and celery in hot oil over medium heat until tender. Stir in soup, milk, and mustard; stir in sausage. Cook and stir until bubbly. Transfer mixture to an ungreased 2-quart rectangular baking dish. Pour corn bread batter over hot sausage mixture, spreading evenly.
3. Bake, uncovered, for 20 to 25 minutes or until a toothpick inserted in corn bread comes out clean. If desired, sprinkle each serving with cheese. Makes 6 servings.

## FORD-MICROSOFT DEAL

Ford Motor Co. says buyers of its electric vehicles won't have to pay extra for software that will help them save money when recharging their cars.

At the New York auto show, the automaker announced a partnership with Microsoft Corp. to develop a computerized link between houses, electric cars and utility companies to help manage energy use.

The companies say it's the beginning of a smart system that will help customers control electric bills.

The Ford-Microsoft system, called Microsoft Holm, would start with the all-electric Ford Focus compact car that is scheduled to go on sale in late 2011. It will allow utilities to vary their rates based on the time of day. A computer would determine the best time to recharge the car at the lowest cost and the least burden on the utility's generating system.

Charging an electric car can double a household's energy use, and utilities worry about taking on the increased burden. But charging the cars late at night, when appliances and other big electricity consumers aren't being used, can help manage the load.

The companies have time to work out details of exactly how the system will work, figuring out electric rates and loads on generating systems, said Derrick Kuzak, Ford's global product development chief. Microsoft already has the technology for home thermostats and appliances to manage electricity use, he said.

"We're doing a lot to bring vehicles to market, but there has to be a lot of other work done from both a consumer and utility perspective to make this viable and affordable," Kuzak said

Many utilities and other companies have been working on similar smart home technology for several years.

## ZENYATTA BREAKS THE RECORD

On June 12 and 13, Nancy Sharmer, Ron Deubner, Etta Black, Don Hobbs and Vic and Wanda Hamshar took a little trip down to Inglewood, CA to see the great Zenyatta run at Hollywood Park.

This was not just any horse race. Of course any race that Zenyatta is in is a BIG race and you know you're going to see a show. But this was BIGGER than big. This was Zenyatta's attempt to break the record of most consecutive wins in modern times. She had already won 16 in a row without ever being defeated.

We drove down on Saturday, had lunch at Hodel's Buffet in Bakersfield, checked into our rooms at our Knott's motel, and had dinner at Po Folks, which was excellent, as usual.



The next morning we got up early and drove to Hollywood Park. This was Don and Etta's first time there. The track gave each person a free Zenyatta bobblehead doll.

They also had Zenyatta limited edition commemorative jerseys for sale, with a portion of the price being donated to Old Friends, a retirement home for retired Thoroughbred race horses in Lexington, KY, and you know I had to have one. Standing in line with the other fans to buy it, I found I'm not alone in my obsession about Zenyatta. We are legion!

We had a table at the Club House Terrace for the day, an open air restaurant with a great view of the race track. Our table was just past the finish line.

Zenyatta's was the eighth race of the day. For most of the day the stands were sparsely populated, but the closer it got to the eighth race, the more people came. When it was time for her race, the place was packed.

We went down to the paddock two races before Zenyatta's so we could get a good spot at the rail to see her close up and personal. If you don't go really early, you don't get to see her. By the time she comes out, the balconies are full, people are on the roof, and the fans are five deep at the rail, trying to get a good look at her. The closer it is to getting to see her, the more excited I get and I can hardly contain myself. Her dance steps and pawing at the dirt are famous.

Zenyatta came into the paddock being led by her groom, Mario, who talks to her constantly. He has to be strong to handle her, as she is hyped up and ready to go. As soon as she appears, the crowd applauds and calls out her name. She went through her dance steps for the crowd and they loved it. Everyone had their cameras out. When she hears the clicks of the cameras, she stops, pricks her ears up and poses.

Inside the paddock were Jerry and Ann Moss, her owners, ( He was previously co-owner of A&M Records with Herb Alpert); John Shirreffs, her trainer, and Dottie, his wife, who is Shirreff's race manager; Bo Derek, who is on the California Racing Board; the composer Burt Bacharach; Julie Krone, a retired Hall of Fame jockey, who was on crutches from a riding accident; and Bob Baffert, a Hall of Fame trainer, who had no horse in this race, but didn't want to miss it. Mike Smith, her jockey, came out to energetic applause, and as soon as the horses were all mounted, we made a mad dash back upstairs to our table so we could see the race.

Zenyatta was carrying 129 pounds, a very high weight these days. She carried 9 to 17 pounds more than the other horses.

As always, Zenyatta was last early on. She loped along behind all the other horses until the clubhouse turn and then started her run. She had to go five or six wide in the lane to pass the other horses, making her lose ground and run farther than all the others, and carrying a lot more weight. She had two very good opponents, Zardana and St. Trinians, who challenged her going to the wire. Getting closer to the finish line, Zenyatta and St. Trinians were head to head, and near the wire Zenyatta gave a couple huge jumps and won by half a length. It was so close people were scared to death and couldn't tell who won. I was having a heart attack! When we found out she actually won, the screaming and yelling from the crowd was deafening. When Mike Smith rode her back to the grandstand to receive the adulation of the crowd, the place went nuts! He paraded her up and down the grandstand area so everyone could get a good look at her, and I was in tears. We saw history in the making.

She's now in the record books, not only for never losing a race and winning more consecutive races, but for winning this particular race three years in a row, which has never been done before. She's now earned \$6,074,580 and is the second highest earning mare in history (so far) after Ouija Board \$6,334,296.

She may run again at Del Mar on August 7<sup>th</sup> and I'm not going to get to go! My sister's wedding is the 8<sup>th</sup> in Las Vegas. Thank goodness for YouTube.

Oh, yes, Vic and Wanda did a little betting on the ponies and Wanda paid for their trip with her winnings.

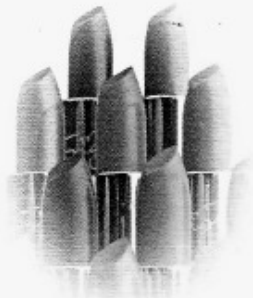
